PRACTICAL CONSUMPTION

Practical coverage depends on many factors such as porosity and roughness of the substrate and material losses during application.

SURFACE PREPARATION

Fassicoat serves as primer, surfacer and finish. Therefore, it is not necessary to use a special primer. In case of application on new and non-treated wood, if necessary, dilute the first coat with ± 3% volume of white spirit. In case of jointing, use Plastopan Super or Pegaflex by preference.

Poor quality wood: user primer FassiForce. Do not apply Fassicoat directly on metallic substrates; in such situation, use a tintable Rust-Oleum anticorrosion primer. Block wood knots and sap streaks with Zinsser primer B-I-N. Block tannin or other typical bleeding substances from redwoods etc, and/or block graffitis, with Zinsser primer Cover-Stain.

DIRECTIONS FOR USE

To ensure homogeneity, coating materials should be thoroughly stirred prior to use.

APPLICATION CONDITIONS

Apply in a dry and well-ventilated area. Temperature minimum 10°C. Relative humidity max. 80%

APPLICATION & THINNING: BRUSH

By preference, apply undiluted with flat brush.

APPLICATION & THINNING: ROLLER

By preference, apply undiluted with flat brush.

APPLICATION & THINNING: AIRLESS SPRAY

Nozzle: 015 / Pressure: 180 bars.

APPLICATION & THINNING: AIR-ATOMISED SPRAY

Possible with maximum 3% volume White Spirit.

CLEANING OF EQUIPMENT / SPILLS

White spirit or Thinner 22

REMARKS

May be applied on slightly damp wood (< 20%).
