170 microns

#### THEORETICAL CONSUMPTION

4-5m²/liter achieves 170-210 microns dry

#### PRACTICAL CONSUMPTION

Typically 4-6m²/liter. Coverage rate may vary depending on size, type and spreading rate of aluminium oxide grits.

#### SURFACE PREPARATION

Apply the aggregate in thewet paint film

## **DIRECTIONS FOR USE**

Temperatures above 25°C and very high humidity will reduce pot life. Application at very low temperatures will significantly retard cure. Do not apply when rain is imminent.

## **APPLICATION & THINNING: BRUSH**

Do not thin

#### **APPLICATION & THINNING: ROLLER**

Apply one coat by roller to give an even spread, ensuring good cover on entire surface. Apply mixed material as soon as possible to maintain workability. Do not thin.

### **CLEANING OF EQUIPMENT / SPILLS**

Thinner 150

Do not apply to inadequately prepared or unsound surfaces. This product should only be applied by Rust-Oleum approved contractors (further details on request). Substrates must be dry during application otherwise curing defects will occur.
