Consumption depends heavily on the surface's rate of absorbency.

#### **DIRECTIONS FOR USE**

Shake Sto-Nex 1 before use. Use this product as supplied. Apply the product in a single layer, taking care that the entire surface is drenched, but avoiding a residue on the surface. Use a (wide) brush or soaper. Take care that the apparatus is free of detergents. Make clean and dry, and remove grease. Avoid leaving a residue of chemicals from cleaning.

Minimum ambient temperature: 5°C Maximum relative humidity: 100% Minimum surface temperature: 5°C Maximum surface temperature: 35°C

#### **CLEANING OF EQUIPMENT / SPILLS**

Rinse with clean water directly after use.
